 - The meeting host will admit you to the meeting once prompted.
- The public may be muted throughout the meeting.
- To make a comment or ask a question, please use the meeting “chat” or “raise hand” features, and follow the below guidelines:
 - Questions and comments for items *not* on the agenda will be addressed during the public comment portion of the meeting. Questions and comments related to specific agenda items will be addressed when the agenda item in question is reached.
 - Questions/comments will be responded to verbally at the discretion of the Environmental Commission Chairman. Written responses will *not* be provided.
