## LEGAL DESCRIPTION

PROPOSED 14 FEET WIDE MERCER COUNTY RIGHT OF WAY EASEMENT ACROSS A PORTION OF PROPOSED LOT 2.02, BLOCK 47 TOWNSHIP OF WEST WINDSOR, MERCER COUNTY STATE OF NEW JERSEY

- 1. ALONG SAID PROPOSED SOUTHERLY LINE OF PRINCETON-HIGHTSTOWN ROAD, SOUTH 76 DEGREES 07 MINUTES 22 SECONDS EAST, A DISTANCE OF 233.26 FEET TO A POINT IN THE SAME WHERE IT IS INTERSECTED BY THE DIVIDING LINE BETWEEN PROPOSED LOTS 2.01 & 2.02, TO BE MARKED BY A CONCRETE MONUMENT SET, THENCE;
- 2. ALONG SAID DIVIDING LINE, SOUTH 13 DEGREES 52 MINUTES 38 SECONDS WEST, A DISTANCE OF 14.00 FEET TO A POINT IN THE SAME, THENCE;
- 3. ACROSS PROPOSED LOT 2.02, BLOCK 47, NORTH 76 DEGREES 07 MINUTES 22 SECONDS WEST, A DISTANCE OF 233.26 FEET TO A POINT IN THE DIVIDING LINE BETWEEN EXISTING LOT 1, BLOCK 47, AND PROPOSED LOT 2.02, BLOCK 47, THENCE;
- 4. ALONG SAID DIVIDING LINE, NORTH 13 DEGREES 52 MINUTES 31 SECONDS EAST, A DISTANCE OF 14.00 FEET TO THE POINT AND PLACE OF BEGINNING.


