- ALONG A LINE LEADING FROM THE EXISTING SOUTHERLY LINE OF PRINCETON-HIGHTSTOWN ROAD TO THE EXISTING WESTERLY LINE OF SOUTHFIELD ROAD, SOUTH 36 DEGREES 51 MINUTES 29 SECONDS EAST, A DISTANCE OF 42.02 FEET TO A POINT, THENCE;
- ALONG SAID EXISTING WESTERLY LINE, SOUTH 03 DEGREES 03 MINUTES 31 SECONDS WEST, A DISTANCE OF 1.43 FEET TO A POINT, 3. THENCE:
- ACROSS EXISTING LOT 5, BLOCK 47, NORTH 76 DEGREES 07 MINUTES 22 SECONDS WEST, A DISTANCE OF 10.18 FEET TO A CONCRETE MONUMENT TO BE SET IN THE PROPOSED WESTERLY LINE OF SOUTHFIELD ROAD AS SHOWN ON THE PREVIOUSLY REFERENCED PLAT, THENCE;

- ALONG SAID PROPOSED SOUTHERLY LINE, NORTH 76 DEGREES 07 MINUTES 22 SECONDS WEST, A DISTANCE OF 450.24 FEET TO AN IRON BAR WITH CAP TO BE SET AT THE INTERSECTION OF SAID SOUTHERLY LINE BY THE DIVIDING LINE BETWEEN EXISTING LOT 1, BLOCK 47 AND PROPOSED LOT 2.02, BLOCK 47 AS SHOWN ON SAID PLAT, THENCE;
- ALONG SAID DIVIDING LINE, NORTH 13 DEGREES 52 MINUTES 31 SECONDS EAST, A DISTANCE OF 14.00 FEET TO THE POINT AND PLACE OF BEGINNING.
