- 1. NORTH 83 DEGREES 57 MINUTES 39 SECONDS WEST, A DISTANCE OF 131.13 FEET TO A POINT OF CURVATURE, SAID POINT TO BE MARKED BY A CONCRETE MONUMENT TO BE SET, THENCE;
- 2. ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 140.00 FEET, A CENTRAL ANGLE OF 31 DEGREES 17 MINUTES 55 SECONDS, AN ARC LENGTH OF 76.48 FEET, A CHORD BEARING OF NORTH 68 DEGREES 18 MINUTES 41 SECONDS WEST, AND A CHORD DISTANCE OF 75.53 FEET TO A CONCRETE MONUMENT TO BE SET, THENCE;

ACROSS PROPOSED LOT 2.01, THE FOLLOWING FOUR (4) COURSES:

- 3. ALONG A CURVE TO THE LEFT, NOT TANGENT TO THE PREVIOUS COURSE, HAVING A RADIUS OF 161.94 FEET, A CENTRAL ANGLE OF 26 DEGREES 34 MINUTES 10 SECONDS, AN ARC LENGTH OF 75.09 FEET, A CHORD BEARING OF SOUTH 69 DEGREES 51 MINUTES 50 SECONDS EAST, AND A CHORD DISTANCE OF 74.42 FEET TO A POINT, THENCE;
- 4. SOUTH 83 DEGREES 21 MINUTES 12 SECONDS EAST, A DISTANCE OF 83.74 FEET TO A POINT OF CURVATURE, THENCE;
- 5. ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 170.00 FEET, A CENTRAL ANGLE OF 15 DEGREES 43 MINUTES 53 SECONDS, AN ARC LENGTH OF 46.68 FEET, A CHORD BEARING OF NORTH 88 DEGREES 46 MINUTES 51 SECONDS EAST, AND A CHORD DISTANCE OF 46.53 FEET TO A POINT, THENCE;
- 6. NORTH 70 DEGREES 59 MINUTES 01 SECONDS EAST, A DISTANCE OF 1.91 FEET TO A POINT IN THE AFORESAID PROPOSED WESTERLY LINE OF SOUTHFIELD ROAD, THENCE;
- 7. ALONG SAID PROPOSED WESTERLY LINE, ALONG A CURVE TO THE RIGHT, NOT TANGENT TO THE PREVIOUS COURSE, HAVING A RADIUS OF 442.10 FEET, A CENTRAL ANGLE OF 01 DEGREES 02 MINUTES 35 SECONDS, AN ARC LENGTH OF 8.05 FEET, A CHORD BEARING OF SOUTH 05 DEGREES 40 MINUTES 41 SECONDS WEST, AND A CHORD DISTANCE OF 8.05 FEET TO THE POINT AND PLACE OF BEGINNING.
