RESOLUTION

WHEREAS, Dynamic Engineering has submitted a request for a reservation of sewer capacity in the public sewer system for the HSC West Windsor, LLC (PB20-09) located at Block 8, Lots 17, 24 and 30; and

WHEREAS, the facilities within the project approved by the Planning Board are estimated to generate 11,060 gallons per day (gpd) total wastewater flow upon construction and occupation of Phase I; and

WHEREAS, the proposed flow and the extension of the collection system on the properties as part of the project require a Treatment Works Approval permit from the New Jersey Department of Environmental Protection; and

WHEREAS, the Township Engineer has certified that there is sufficient capacity in the existing downstream sanitary sewer system to accommodate the increase in average daily flow of 11,060 gpd of wastewater that is estimated to be generated by the proposed improvements, once completed and occupied.

RESOLUTION

WHEREAS, the Township of West Windsor has a need to increase capacity of the municipal wastewater collection system in the Southfield Road Pump Station and South Post Road Pump Station watersheds in order to accommodate wastewater flow from recently approved and proposed future development projects, including several required as part of the Township's Fair Share Plan approved by the court; and

WHEREAS, the Sewer Capacity Analysis performed by the Township's consultant, ACT Engineers, has determined that the projected development flow based on current zoning will require the Southfield Road Pump Station to have a minimum pump capacity of 596 GPM and South Post Road Pump Station upgraded to a minimum pump capacity of 1419 GPM; and

WHEREAS, the improvements required to achieve these capacities at each pump station and within the municipal collection system require a Treatment Works Approval Permit application be submitted to the New Jersey Department of Environmental Protection; and

WHEREAS, individual property owners within these watersheds remain required to individually pursue requests for reservation of capacity and all other regulatory and statutory approvals, independent of the Township's activities to increase sewer capacity.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of West Windsor endorses the increase of capacity within the municipal collection system.

BE IT FURTHER RESOLVED, that the Township Engineer be and hereby is authorized to execute the endorsement of the New Jersey Department of Environmental Protection Treatment Works Approval Permit application, as required to implement this Resolution, upon submission of final design/construction plans and specifications acceptable to the Township Engineer.

WHEREAS, the Tax Collector is requesting that unpaid sewer rent charges shall be charged interest after March 31, 2022 back to the original due dates.

NOW THEREFORE, BE IT RESOLVED by the Township Council of Township of West Windsor that the date to charge interest on the payment of unpaid sewer rent charges be extended from March 15<sup>th</sup> to March 31<sup>st</sup>; and

BE IT FURTHER RESOLVED that in accordance with N.J.S.A. 54:4-67, interest calculated on payments received after March 31, 2022 will revert back to the original due date of when each sewer rent charge was billed.
