Update from Health Officer on Clinics

Ms. Swanson provided an update on flu clinics for Council.

A short discussion ensued between members of Council and Ms. Swanson regarding statistics for various flu statistics.

Ms. Swanson reported Rabies Clinics will be held at the following locations:

Ms. Swanson advised that the quarterly report on Board of Health activities was transmitted to Council last week.

Discussion Lead Safe Housing Draft Ordinance

Ms. Swanson reviewed the requirements by the Department of Community Affairs for inspections for lead in rental properties built prior to 1978. She reviewed the process and advised that every three years these properties will need to be re-inspected unless there is a turn-over in the tenant prior to that. She advised the draft ordinance also sets the fees for these inspections. She noted the landlord has the right to hire a private inspection company if they so choose.

Members of Council asked various questions regarding this ordinance of which Ms. Swanson addressed them.


Ms. Swanson requested the ordinance be placed on the next Council meeting for introduction.
